**Explanation of Responses:**

- Restricted stock units convert to common stock on a one-for-one basis.
- Shares acquired upon settlement of performance stock units granted on February 22, 2023, following the end of a three-year performance period 2023-2025 (Performance Cycle). The amount earned during the Performance Cycle is based on the satisfaction of performance against three separate financial metrics.
- Disposition to the Issuer of shares to satisfy the Reporting Person's tax withholding obligation upon vesting and settlement of stock units which is exempt under Rule 16b-3.
- Holdings as of reportable transaction date include additional acquisitions and dividend reinvestment under the company's 401(k) plan.
- On February 22, 2023, the reporting person was granted 2,627 restricted stock units, the remaining unvested portion of which vested on the third anniversary of the grant date.
