The phantom stock units were acquired at \$82.01 per share and vest 50% on June 30 following the award date and 50% on December 31 following the award date or, if earlier, upon retirement, death, disability or change in control. Settlement in cash or stock (as elected by the director) will occur upon the reporting person's retirement or termination of service.
- End of period holdings include phantom stock units acquired through dividend reinvestment.
