2. Phantom stock units acquired under the Lockheed Martin Supplemental Salaried Savings Plan exempt under Section 16(b) which will be settled in cash upon the reporting person's retirement or termination of service. The phantom stock units convert on a one-for-one basis. Includes .7115 units held under the Lockheed Martin Corporation Nonqualified Capital Accumulation Plan.
